The third time was a charm for Monarch Partners Asset Management, which after two years as a finalist in the smid-cap manager of the year category, was able to break through and finally land a Manager of the Year award.

The firm was bolstered in 2014 by a signficant growth in assets in the strategy that ranked among the highest for smid-cap managers in both amount and percentage growth.

The Boston-based firm was launched in 2010 by Wayne Archambo and is 100% employee owned.

In all, 378 products were considered for the awards. Winners will be taking home a crystal award engraved with their firm nameand the asset class they were recognized for.
